GARBAGE:

Items NOT picked up: Animal waste, car parts, oil, antifreeze, hazardous waste, hot ashes, liquids, paint cans, shingles, tires and yard waste. (Note: see City Hazardous Waste collection in August. Info in Summer Newsletter). Please place glass or sharp items in a secure container such as a box and clearly label contents "Glass".

NOTE: IF GARBAGE IS NOT PICKED UP IN 2 CONSECUTIVE WEEKS, A TRUCK WILL BE SENT OUT for NEXT DAY COLLECTION ACCORDING TO WASTE MANAGEMENT.

The large oak tree in the center of the Sherman Twp. Cemetery is dead from oak wilt. It will be removed in 2021. A DNR Forester has diagnosed oak wilt in the surrounding area. It is a deadly and contagious disease for our oaks. Please do not trim, cut or damage oaks from May through first frost to help control the disease.
