- -Supervisor Jurgensen presented an estimate from the DeLisle Landscaping & Excavating company for the Grass Lake Subdivision work to be done in July.
- -Supervisor John Jurgensen reported that excavating for the Township Expansion will start next week on Monday 5/22/23.
- -Supervisor Jurgensen announced that he had looked into recycling; in the pst and it was very expensive.
- -Supervisor Jurgensen reported that brining for the Township is scheduled to be done May 31st.
- -Clerk Kay Whalen made a motion to accept the Supervisor's report and Trustee Sarah Paisley supported. ALL AYES. M/C.

Assessor Report

- -Assessor Corey Cuddie reported that she has already moved in 2024 evaluations and that she has recently completed the Commercial & Industrial class for Assessing.
- -Assessor Cuddie also reported that the Assessment Audit could be any day now.
- -Supervisor John Jurgensen made a motion to accept the Assessor's report and Clerk Whalen supported. ALL AYES. M/C.

Blight Report

-Supervisor Jurgensen presented the written report from Blight Officer, Jon Freier-Woods and there were no questions.

Old Business

- -As reported earlier by Clerk Whalen, the Township has received approval on their Election Security Grant and a check is forthcoming.
- -Supervisor Jurgensen reported that our request for the PAR Plan Insurance Grant was denied as it was written out versus being typed. He will resubmit the request on the next cycle; August 1st, 2023.
- -No information has been made available to the Clerk from the State for a Voting Drop Box order.

New Business

- -Supervisor Jurgensen reported that Congressman John Moolenaar would be hosting a Veterans & Military Resource Fair on May 19th @ 11AM in Big Rapids. Congressman John Moolenaar will be at the Gladwin County Building MAY 25, 2023 from 10-11AM.
- -Treasurer Jean Jurgensen made a motion to make a 2022/2023 budget adjustment of \$243 with the money being moved from line item 101-958 to line item 253-830 and Clerk Whalen supported. ALL AYES. M/C.
- -Supervisor Jurgensen presented a proposal from AAA Plumbing & Heating to add an A/C unit to the Township Hall for the entire building. This item will be discussed at a future date.
- -Supervisor Jurgensen presented a quote from ISP (our internet service) regarding Security Cameras for the hall (a security camera is a State requirement for the Voting Box). The system would be installed before next year's elections.
- -The 9 day voting plan is still unclear at this time and will be discussed at a future meeting.
- -Treasurer Jurgensen asked if there were any questions regarding the 2023/2024 budget and there were none. She pointed out that there is a 2% salary increase for the Assessor and Board Members in the budget along with a new line item to be used for the expenses from the Township Expansion (101-265-971)
