-County Commissioner, Mike Visnaw, reported that the Circuit Court of Gladwin shares Judges with Clare County. He also reported that due to a recent job vacancy the County will be saving \$18,000.00.

-Commissioner Visnaw reported that the Sheriff's office is in the process of hiring more staff.

## **Treasurer's Report**

- -Treasurer Jean Jurgensen presented her monthly financial report of Township funds.
- -Treasurer Jurgensen reported that the Township received a Swamp Tax and Constitutional Sales Tax from the State of Michigan.
- -Treasurer Jurgensen reported that our credit union, MFCU, had a "vendor outage" and we have been unable to get a paper copy of December's transactions.
- -Treasurer Jurgensen also announced that the road assessment for the Grass Lake did not appear on the recent Winter Tax bill but that the amount listed for taxes were correct. The assessment did not appear on the bill itself because the County Equalization Department (who generates the

bills for the Township) ran out of room to list that item. Treasurer Jurgensen asked County Commissioner, Mike Visnaw, to look into that for the Township so this doesn't happen again in the future.

-Upon receiving the latest bill from Hardwood Hills for the Township Expansion, Treasurer Jurgensen reported that it was accurate per the contract.

- -Treasurer Jurgensen asked if there were any questions and there were none.

## **Trustee's Report**

-Supervisor Jurgensen handed out the minutes from the Gladwin Rural Urban Fire District meeting.
